Program](#), an initiative from technology consulting firm Sharp Decisions that puts military veterans through intense, "boot camp" training for IT careers and then deploys them in squads of 3-4 into U.S. corporations like Harmonic, emulating the platoon-based culture in which they thrived in combat theater. The program is free to veterans.

"At Harmonic, our goal is to hire smart people who do great work and these veterans clearly meet that standard," said Chris Pattinson, Vice President of Global Software Quality Assurance at Harmonic. "We are partnering with the V.E.T.S. Program because veterans have special traits that we value on our team: exceptional work ethic, teamwork and grace under pressure. The V.E.T.S. Program is not just good for veterans – it is good for our business."

V.E.T.S. stands for Vocation, Education, & Training for Service members. Five veterans have been deployed to Harmonic from V.E.T.S., performing tasks ranging from quality assurance to performance analysis. According to the U.S. Bureau of Labor Statistics, the unemployment rate for California veterans stands at 7.4 percent - much higher than the national veterans' average of 5.3 percent.

The V.E.T.S. program breaks the mold for veterans' employment efforts by emphasizing military-style training and platoon-based deployments for veterans. Through V.E.T.S., award-winning strategic technology consulting firm Sharp Decisions hires tech-savvy, U.S. armed forces veterans as full-time salaried/benefited employees who undergo intensive, boot camp-like technology training before being deployed in squads of 3-4 into companies like Harmonic to perform high-demand information technology work.
