Among the other benefits, it eliminates the need to store multiple instances of the program in order to support different usage scenarios such as regular play and trick play for fast forward and rewind. By encrypting content at the leading-edge of the open network, the NSG with Privacy Mode makes it possible for operators to increase their revenue potential by refreshing advertisements within narrowcast streams. Dynamically splicing advertisements also allows operators to increase the level of personalization by targeting based on the viewer's location and/or demographics.
